SELECTION PROCESS**

With the Jury Application(s) include:

- Four (4) 3" x 5" or 4" x 6" photographs. (**Please do NOT send more than four photographs or photographs larger than the sizes noted.**) The quality of the photos is of utmost importance; they are our only means of jurying your work.
- Label each photo on the back with artist's name and category to be juried.
- Jury fee of \$25 (non-refundable), postmarked no later than **February 1, 2007.**

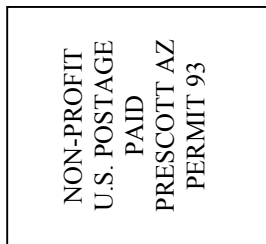
There may be a 2nd jury process for applications postmarked after 2/1/2007. Those applications require a **\$50.00** (non-refundable) fee per category.

- Self-addressed, stamped envelope (SASE) for jury decision. (NOTE: If you wish to have your photos returned, please enclose an additional SASE of the proper size and appropriate postage with your application.)

Images must clearly reflect our mission statement: *To perpetuate the unique heritage, mythology, and influence of American Western Art.*

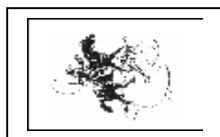

Jurying is conducted by a panel of experienced art professionals and is based solely upon the quality of work as illustrated in submitted photographs. Jury decisions are final.

BOOTH INFORMATION

There are approximately 160 booth spaces available. Artists will be allocated a minimum of 10' x 15' space for a booth. Electrical power is available for a limited number of booths (at an additional fee). Artists must provide their own display equipment, lighting, extension cords, etc. Canopies are recommended, but not required. Further information concerning site specifics will be provided with the artist acceptance packet.

If juried into the show, all fees, including the booth fee of \$425, will be due by April 1, 2007. Do not send fees until notified of acceptance. Booth spaces are assigned on a first-paid basis. All revenue from the sale of the artwork will be retained by the artist. Artists are responsible for any sales taxes.

THE SHOW

This highly-publicized annual outdoor show will be held over Memorial Day weekend (May 26, 27 & 28, 2007) in beautiful downtown Prescott, Arizona. Please note, there are rules and regulations pertaining to the use of the Courthouse Plaza that are NOT rules of the PHIPPEN MUSEUM. These rules must be complied with during the show and will be provided in the artist acceptance packet sent to you once your artwork has been juried and accepted. The Phippen Museum will promote the Art Show with display advertisements, newspaper articles, radio, and television.

ELIGIBILITY

The show is open to all artists submitting work featuring **Art of the American West** in the following seven media categories: Acrylic, Drawing, Mixed Media, Oil, Pastel, Sculpture, and Watercolor. Participation in any previous show does not guarantee acceptance. Awards will be given in each medium category.
